| <b>Certification Statements:</b><br><br>1. The pet birds were hatched and raised or have been, for at least 30 days prior to the exportation, in the United States.<br><br>2. The United States is officially free from high pathogenic avian influenza (HPAI) in accordance with the OIE and Korea's import health requirements for birds other than poultry.<br><br>3. The pet birds have been isolated in quarantine facilities approved by the USDA for at least 21 days prior to shipment and inspected by a USDA-accredited veterinarian and were found to be free of any evidence of infectious poultry diseases.<br><br>4. The pet birds are being transported in new, cleaned, and disinfected (with a disinfectant acceptable to APHIS) containers.<br><br>5.
