IV. HEALTH ATTESTATION

- I, the undersigned veterinary officer of the Government of the Netherlands herewith declare that:
- 1. The beef for export is derived from cattle born and raised in the Netherlands or derived from cattle born and raised in a country approved for export of beef to the Republic of Korea by the Korean authorities and legally imported to the Netherlands.
- 2. "Beef for export" includes all edible parts produced from cattle of less than 30 months at the time of slaughter. However, the following materials are excluded:
 - a. Brains, eyes, spinal cord, skull (excluding mandible) and vertebral column (excluding verte brae of the tail, transverse processes of the thoracic and lumbar vertebrae and wings of the sacrum), intestines from duodenum to rectum, including distal ileum, and tonsils of cattle of less than 30 months at the time of slaughter;
 - b. All mechanically recovered meat (MRM) / mechanically separated meat (MSM) and advanced meat recovery products (AMR);
 - c. Ground meat and processed beef products.
- 3. The beef for export has been produced from cattle, that are not suspected or confirmed BSE cases, and do not descend from confirmed progenies or cohorts of BSE cases.
- 4. The beef for export is derived from cattle that were slaughtered in establishments which are approved by the Korean government.
- 5. The beef for export is found to be suitable for human consumption after ante-mortem inspection conducted by the inspection officials of the Netherlands government and after post-mortem inspection conducted by the inspection officials of the Netherlands government or inspectors under control of such government inspection officials.
- 6. The beef for export has been derived from cattle that were not subjected to a stunning process prior to slaughter, with a device injecting compressed air or gas into the cranial cavity or to a pithing process.
- 7. Establishments that produce beef for export to Korea have in place and operate proper sanitation control programs that include the determination of age, removal of ineligible parts as defined in article 2.a and 2.b of this health attestation, measures to prevent cross-contamination with the ineligibles parts and identification of carcass and offal eligible for export.

 In addition, the exporting country's government should approve such programs and audit these establishments at least once a year to verify their compliance with these programs.
- 8. The beef for export is produced and handled in a manner which ensures that it does not contain and is not contaminated with ineligible parts as defined in article 2.a. and 2.b. of this health attestation.
- 9. The age of the cattle for beef for export is verified to be less than 30 months through the exporting country's traceability system (including documentation) by the government inspection officials (veterinarians) or inspectors at slaughter.
- 10. The export establishment establishes and operates its own monitoring plan in accordance with the EU regulations for residual substances notified by the Korean government including animal drugs, agricultural chemicals, heavy metals and other relevant substances, the plan complies with the Korean maximum residue limits for all notified substances and all relevant records are maintained for 2 years.
- 11. The export establishment regularly performs microbiological monitoring for Salmonella, enterohemorrhagic Escherichia coli, Enterobacteriaceae and aerobic colony count and maintains its monitoring records for 2 years.
 In addition, if test results exceed limits in accordance with the relevant EU regulations for Salmonella, Enterobacteriaceae & aerobic colony count and any positive results are observed for enterohemorrhagic Escherichia coli, appropriate actions are taken to improve such establishment's sanitary conditions and relevant records are maintained for 2 years.
- 12. Prior to the loading of the beef, the Netherlands has been free from foot-and-mouth disease for the past 12 months, and has been free from rinderpest, contagious bovine pleuropneumonia, lumpy skin disease and Rift Valley fever for the past 24 months; and vaccination has not been carried out against the aforementioned diseases.
- 13. Beef for export should be handled, packaged, stored and controlled in such a sanitary manner as to prevent contamination by communicable animal disease pathogens and pathogenic bacteria.
- 14. Refrigerator or cold storage rooms on a vessel (aircraft) or container that transports the beef are sealed by using the seal of the Netherlands government or the Netherlands government-authorized seal. An official veterinarian of the Netherlands government has verified this and issue a health certificate.
